

MUJI BULLET JOURNAL ESSENTIALS KIT GIVEAWAY – OFFICIAL RULES

5. WINNER SELECTION: The Winner(s) of the Sweepstakes (“Winner(s)”) will be selected in a random drawing from among all eligible Entries received throughout the Promotion Period. The random drawing will be conducted within twenty-four (24) hours at the end of the Promotion Period by Sponsor or its designated representatives, whose decisions are final.
